

Changes to the General Achievement Test

The General Achievement Test (GAT) is changing.

The Victorian Government is reforming career education and senior secondary pathways. From 2023 we will be transitioning the VCE and VCAL to a new integrated senior secondary certificate. As part of the reform of the VCE and VCAL system, Victorian senior secondary students will this year have their literacy and numeracy skills measured against new standards in a reformed GAT.

The new standards will indicate whether students have demonstrated the literacy and numeracy skills typically expected of someone completing their secondary schooling – giving another indication of their readiness to move onto further education,

training or employment.

The 2022 GAT will be held on Wednesday 7 September. The slightly later test date provides the time required to make sure the revised GAT is valid and reliable, and for teachers and students to understand the changes – with the test expected to return to its traditional June date from 2023.

The reformed GAT follows a comprehensive review conducted by the VCAA. It will see Victoria join other jurisdictions who already incorporate literacy and numeracy standards as part of their senior secondary reporting.

Senior secondary certificate transition

As you know, Victoria is moving to a new integrated senior secondary certificate that brings together our VCE and VCAL certificates. We have developed additional supports for you to use in the transition from VCAL to the VCE Vocational Major and the Victorian Pathways Certificate in 2023.

Professional learning to support the implementation of the VCE Vocational Major and Victorian Pathways Certificate will be offered throughout the year, and we will share a detailed list of dates soon. This professional learning will support all schools, including those that don't currently offer VCAL, to develop engaging vocational and applied learning programs for students.

The proposed curriculum is currently being considered for accreditation by the Victorian Registration and Qualifications Authority. For more information about the new pathways, visit our page on <u>Senior Secondary Certificate Reform.</u>

General Achievement Test improvements

2022 will also see positive changes to the GAT, with the introduction of new measures to assess literacy and numeracy skills and broadening it to include Senior VCAL students who will now sit a section of the GAT. It is vital that our young people attain the reading and writing skills to be able to fully participate in today's workforce. The reformed GAT will provide additional information on the skills and knowledge that students have gained, which will be of value to them, schools and employers.

Transition to NAPLAN Online

The national transition to NAPLAN Online is due to conclude in May 2022, with all Victorian schools expected to administer NAPLAN Online this year. Schools are required to undertake a number or key readiness tasks to complete the NAPLAN Online school readiness program.

In addition to a webinar training program, a set of self-directed online courses are available through our website. There are four role-based courses available for principals, NAPLAN coordinators, test administrators and technical support officers. All courses are available on-demand throughout the remainder of 2022. I encourage staff in the designated roles to access the appropriate course. Please refer to the F–10 Assessment section of this Bulletin for more details.

VCE Season of Excellence 2022 commences soon

Preparations for the VCE Season of Excellence are in full swing. Following Top Class Music selection panels held on Saturday 5 February and Sunday 6 February, all exhibitions and concerts have now been programmed, and the full cohort of Season 2022 participants has been confirmed. Our congratulations to all students who were shortlisted and selected for this year!

The VCE Season of Excellence includes Top Talks, Top Designs, Top Class Dance, Top Class Sound, Top Class Music, Top Class Drama and Theatre Studies, Top Arts, Top Screen and Top Acts. It showcases exemplary works by VCE and VCE VET students from 2021 across the performing arts, technology, design, visual arts and research studies.

The Season will kick off with Top Talks on the morning of Friday 4 March at State Library Victoria. Four Extended Investigation students will share their independent research in 10-minute presentations. While in-person bookings are now sold out, the event will also be live streamed, and online bookings are available via the State Library Victoria.

By now, we are accustomed to adaptation and this year we have delayed Top Class programming to ensure the safety of all performers. The Top Class Dance concert will now be held on Wednesday 16 March, while Top Class Sound will be amalgamated with the Top Class Music concert at 1pm on Tuesday 22 March.

There are a wide variety of works in Top Designs this year, including works that represent four VCE VET studies: Integrated Technologies, Music Industry (Sound Production), Creative and Digital Media, and Furnishing. Professional learning: Introducing the Victorian Curriculum F-10 and assessment

Starting in early March and running throughout Semester 1, we are hosting a series of webinars on the Victorian Curriculum F-10 and assessment. Designed for teachers new to the curriculum, each webinar will focus on a specific curriculum area, and will cover topics such as the sound principles of assessment, using the curriculum to support assessment of student learning, and assessment and reporting. Each webinar will provide opportunities for participants to ask questions directly to the relevant VCAA Curriculum Manager.

Bushfire Education website has moved

The <u>Bushfire Education</u> website, which has lesson plans and resources aligned to the Victorian Curriculum, has moved and is now accessible via our website.

Organised under the themes of learning about, preparing for, responding to and recovering from bushfires, the aim of the lesson plans is to better prepare all young Australians for the challenges of living in a country that regularly experiences bushfires. Each lesson plan has a specific learning intention and links to the relevant curriculum areas and additional resources.

The Elements of Dance and The Elements of Drama posters, F-10

These 10 downloadable Dance posters and eight downloadable Drama posters have been designed to support the learning of Dance and Drama in primary and secondary classrooms. Dance and Drama are learnt through developing skills and knowledge associated with the elements of dance (such as space, time and dynamics) and the elements of drama (such as character, focus and movement). The posters make visible the basic concepts and vocabulary associated with these elements.

Teachers and schools are encouraged to download, print and display the A3 posters.

Geography: Using geospatial technologies videos

This series of <u>videos</u> provides teachers with an understanding of how to integrate geospatial technology tools into teaching and learning programs for Victorian Curriculum F–10 Geography. Each video shows how three or more geospatial technology tools can be used in an example scenario related to content descriptions in the Geography curriculum. The videos demonstrate how teachers can integrate these tools into their teaching and learning programs, incorporating locations that support their particular school context.

Health and Physical Education learning modules, F-6: Tell us what you think

We have produced a <u>series of innovative learning modules</u> to support primary school teachers to plan, implement and assess using the F–6 Health and Physical Education curriculum.

Teachers can work through the four modules at their own pace. Each module begins with an introduction to the topic, followed by two or more video presentations and a resources page with links to readings and other third-party resources. Some modules have a non-compulsory quiz to test your knowledge and understanding.

We encourage primary schools and HPE teachers to explore these targeted resources, either completing each module sequentially or selecting those that are most appropriate to their professional learning needs.

New annotated work samples for Home Economics, F-10

These <u>annotated Home Economics student work samples</u> accompany the sample units of work and associated summative assessment tasks published in 2021. These resources have been designed to show how Home Economics teaching and learning programs can draw on both the Design and Technologies and Health and Physical Education curriculum areas of the Victorian Curriculum F–10.

Each student work sample is assessed against an assessment rubric that is explicitly linked to the Design and Technologies and Health and Physical Education curriculum areas, and is accompanied by a breakdown of the student's learning and an explanation of what they will be ready to learn next.

New resources to help unpack the Languages curriculum, F-10

These new easy-to-use <u>Languages resources</u> contain ideas and advice to help teachers unpack content descriptions and achievement standards from the Victorian Curriculum F-10 Languages curriculum.

Each resource addresses either Levels F-6 or 7-10 in an example Language (for example, Modern Greek) and includes example activities based around one central theme (for example, Celebrations). Teachers of any Language can adapt these examples and develop units of work tailored to a related theme specific to their chosen language and culture.

New Science resources that explore biological sciences in local and Victorian contexts, F-6

This <u>new sample learning resource to support the Science curriculum</u>, F-6 includes learning activities, detailed tasks and case studies based on local and Victorian contexts – from exploring the variations that occur in local and other Victorian frog species to investigating the effects of drought on farms and farm animals in rural Victoria.

Learning science concepts in relation to local and relevant contexts supports students in making connections and links to scientific ideas in the physical world. It helps them to see the 'why' behind their learning and provides a rationale for exploring and understanding the world around them.

More Science resources to support the understanding of forces and motion

Access a new Levels 7 and 8 Science resource to support the understanding of forces and motion. This resource joins the suite of F–6 resources published in 2021. It features hands-on classroom learning activities to help students explore how forces can act to cause a change in motion and learn more about the concept of balanced and unbalanced forces.

An <u>accompanying overview document</u> demonstrates how student learning from Foundation to Level 10 fits into the broader forces and motion story, plus unpacks some common student misconceptions about forces and motion.

NAPLAN

2022 test dates

Schools are reminded that NAPLAN tests will take place from Tuesday 10 to Friday 20 May.

The tests must be administered in the order, on the dates and within the times specified in the timetables provided in the 2022 Handbook for principals – NAPLAN Online. Under no circumstances may a test be conducted before the official test date or time. Please note that the NAPLAN test security period is until Friday 3 June.

NAPLAN principals' package

The NAPLAN 2022 principals' packages were delivered to schools from Friday 28 January. If you have not received the principals' package, please contact the NAPLAN helpdesk on 1800 648 637.

This package includes the <u>2022 Handbook for principals – NAPLAN Online</u>, the Important information for NAPLAN 2022 document and a cover letter that contains a new password to access the Test Administration website and VCAA Data Service.

2022 writing test information

As in previous years, there will be two writing prompts: one for Years 3 and 5 and a different one for Years 7 and 9. The genre for the NAPLAN 2022 writing test will be either narrative or persuasive, and it will be the same genre for all year levels. The genre for the writing test will not be disclosed before the test day and students will not be able to choose the genre in which they write their response.

The Year 3 writing test will be conducted using paper tests for all schools.

The NAPLAN Test Administration website

The <u>NAPLAN Test Administration</u> website enables schools to complete a range of administrative tasks online. This secure site requires a user ID and password to log in. The login details are provided to principals in the letter accompanying the NAPLAN 2022 principals' package.

The website is currently available for the enrolment phase. During this phase all schools are asked to complete the following tasks:

- Friday 11 February student enrolment
- Friday 18 February Statement of Compliance, register authorised staff and review school contact and address details
- Friday 25 February Technical Readiness Check and initial NAPLAN test schedule

Chemistry, English, English as an Additional Language and Physics will have a staged implementation, with Units 1 and 2 to be implemented in 2023 and Units 3 and 4 to be implemented in 2024.

These updated study designs are published online during Term 1 in the year before implementation on the relevant VCE study webpage. This is to assist teachers to prepare for the implementation of the reaccredited studies in 2023 and must not be used for the 2022 academic year.

Updates and amendments to study designs are announced in the Bulletin and published on individual study pages.

2022 VCAA Consultation Register now open

Consultation is an important part of the review and accreditation process for VCE studies. The consultation process is conducted electronically and teachers and stakeholders are invited to participate by joining the <u>VCAA Consultation Register</u> for the following VCE studies:

VCE Music Investigation and VCE Music Performance

Updated playlists

The 2022 solo and group lists of works are now available on the VCE Music Investigation and the VCE Music Performance study pages. The same lists are used for Units 3 and 4 of both Music Investigation and Music Performance. Information about study specific requirements is provided in the lists.

For the majority of listed works, the cited editions are only recommended, and equivalent editions may be used without seeking VCAA approval. Where a work is a specific arrangement or a transcription, it will have been generally published only in the cited edition. It is the responsibility of schools to ensure students perform only listed works or approved alternative works.

Alternative works and instruments

Guidelines and application forms for approval of alternative works and instruments for solo performance are available on the VCE Music Investigation and VCE Music Performance study pages.

Separate guidelines and application forms are provided for VCE Music Investigation and VCE Music Performance. These forms must be submitted by 5pm on Wednesday 23 February.

All VCE Music Lists will be reviewed in line with the revised VCE Music study design, due to commence in 2023. New lists will be published for use in 2023.

VCE Music Investigation topic approval

Students enrolled in VCE Music Investigation Units 3 and 4 must complete an Investigation Topic Approval form, available from the VCE Music Investigation study page. Schools must submit the completed form via VASS (go to Student Program > VCE > Approved Focus Area) by 5pm on Wednesday 23 February.

It is the school's responsibility to:

- make sure each student is correctly enrolled in the study (VASS code MC05 3-4)
- enter the correct focus (instrument) code (a list of codes is available as a VASS download)
- submit a separate application for an alternative instrument, if applicable
- submit a separate application for an alternative work, if applicable.

Schools are not required to submit sheet music or audio files at this stage. We will reply 'approved' or 'not approved' during March to the person identified on VASS as the Music Investigation school contact person. During the approval process, we may contact schools and request copies of sheet music and audio recordings of prescribed works.

New VCE VET program - VCE VET Visual Arts

The new VCE VET Visual Arts program will offer the opportunity for students to complete the Certificate II in Visual Arts and the Certificate III in Visual Arts. Both qualifications provide students with occupational outcomes and pathway opportunities.

Before 2022, Certificate II and III in Visual Arts were recognised by VCAA certificate type VE3. From 2022, Certificate II and III in Visual Arts will be recognised by VCAA certificate type VE1.

Students undertaking CUA20720 Certificate II in Visual Arts are eligible for up to four VCE VET units on their VCE or VCAL statement of results, at Units 1 and 2 level.

Students undertaking CUA31120 Certificate III in Visual Arts are eligible for up to six VCE VET units on their VCE or VCAL statement of results, up to two VCE VET Units at Units 1 and 2 level and up to two non-scored Units 3–4 sequences.

VCE VET Visual Arts is complementary to existing VCE Arts Studies, as well as a practical option for students seeking an alternative to VCE Arts Studies.

If a student wishes to undertake VCE VET Visual Arts in addition to either of the VCE Visual Arts studies, care should be taken in selecting electives that do not duplicate artistic disciplines.
